This issue of the INTERNATIONAL JOURNAL OF LEGAL INFORMATION (IJLI) is the proceedings issue for the International Association of Law Libraries (IALL) twenty-eighth Course on International Law Librarianship. The conference was held in Istanbul, Turkey from the 11<sup>th</sup> to the 15<sup>th</sup> of October, 2009.

Istanbul is one of the more exotic locations for the IALL's annual meeting in recent years. Expectations among delegates to the conference were high, and the local planning committee met those expectations.
