Instructions to Authors

Manuscripts should be double-spaced, clearly typed, on single-sided, A4 sized paper with 1.5" wide margin on the left and 0.5" on the right. It should include professionally-drawn tables, maps, and other illustrations. These should be camera-ready and must be provided wherever possible along with the manuscript. These must be numbered accordingly (e.g. table 1, table 2, etc.) and with a title at the top. The manuscript should be accompanied by the author's signed declaration indicating that the paper has not previously been published or is not currently under consideration for publication elsewhere.

Manuscripts must be journal article length (10, 000 to 12,000 words). No manuscript should ordinarily exceed 24 typed pages, including graphs, tables and appendices. Every manuscript must include an abstract of no longer than 250 words, typed on a separate paper.

Papers should be submitted ready for blind review. The cover page of the manuscript should contain the title of the paper, author's name, mailing and e-mail address, and professional affiliation. The first page of the paper must provide the title of the paper. It should not give the author's name or address. The author's name should appear nowhere in the manuscript except right after the title page. The author should avoid references to his own scholarship that identify him/her as the author of the article. For example, avoid phrases like: "As I have shown in another article..." or "see my recent article ...")

Manuscripts should be presented in the following order: (i) title page, (ii) abstract and key words, (iii) text, (iv) acknowledgements, (v) references, (vi) footnotes, (vii) appendices, (viii) figure legends, (ix) tables, and (x) figures.

The Harvard (author, date) system of referencing is used. See Chicago Manual of Style. In the text authors must give their name followed by year in parentheses: Wood (2000). If there are two authors use "and": Wood and Gamble (2001). If there are four or more authors: MacDonald et al (2002).
